The Medical Marijuana Commission meeting was called to order by Chairman James Miller. Chairman Miller and Commissioners Pool, Ketner, and Case appeared in person; Commissioner Thomas was absent. The first item of business was approval of the minutes. After reviewing the minutes, Commissioner Case made a motion to approve the minutes which was seconded by Commissioner Ketner and approved by vote of 4-0.

The next agenda items were the renewals of dispensaries, cultivators, and processors. ABC Director, Christy Bjornson, and counsel from the Attorney General's Office found no issues with any of the dispensaries. Moving through each item, Director, Christy Bjornson, and counsel from the Attorney General's Office stated whether issues were found, and the Commissioners made motions to approve each:

ABC Director, Bjornson also notified the Commission of the floor plan change for Dark Horse Medicinals. Each notice item was recognized by the Chairman and Commissioners.

Next, were the transfers of ownership. The first transfer was for License 88. Natural State Medicinals, where no issues were found by ABC or the AG's Office. Chairman Miller made a motion to approve, Commissioner Pool seconded, and the motion was passed with a 4-0 vote. The second was for License 58. Enlightened Morrilton, where no issues were found by ABC or the AG's Office. Commissioner Pool made a motion to approve, Commissioner Ketner seconded, and the motion was passed with a 4-0 vote. The third was for License for 81. GDF Hensley, where no issues were found by ABC, but issues were found by the AG's Office, and the item was pulled and tabled to the June meeting.

The next item of business was Administrative Matters with Jordan Broyles providing the Commission with a litigation update. Chairman Miller requested to discuss Rules during the June meeting, placing it under "Administrative Matters," and ABC Director Bjornson agreed.

Lastly, the Commission and ABC Director Bjornson discussed setting the upcoming meeting dates. The Commission approved the following dates:
